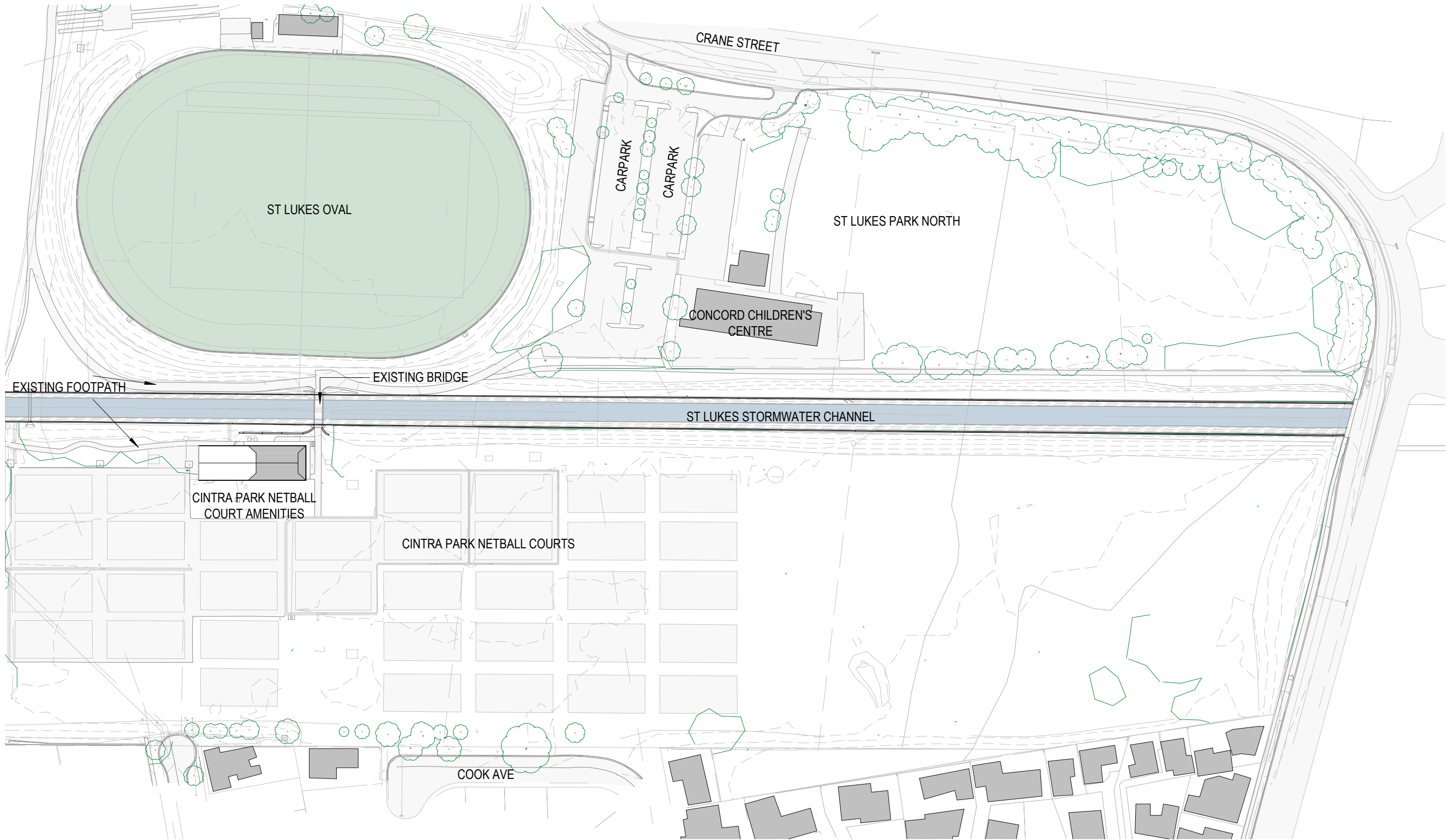

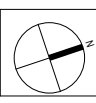

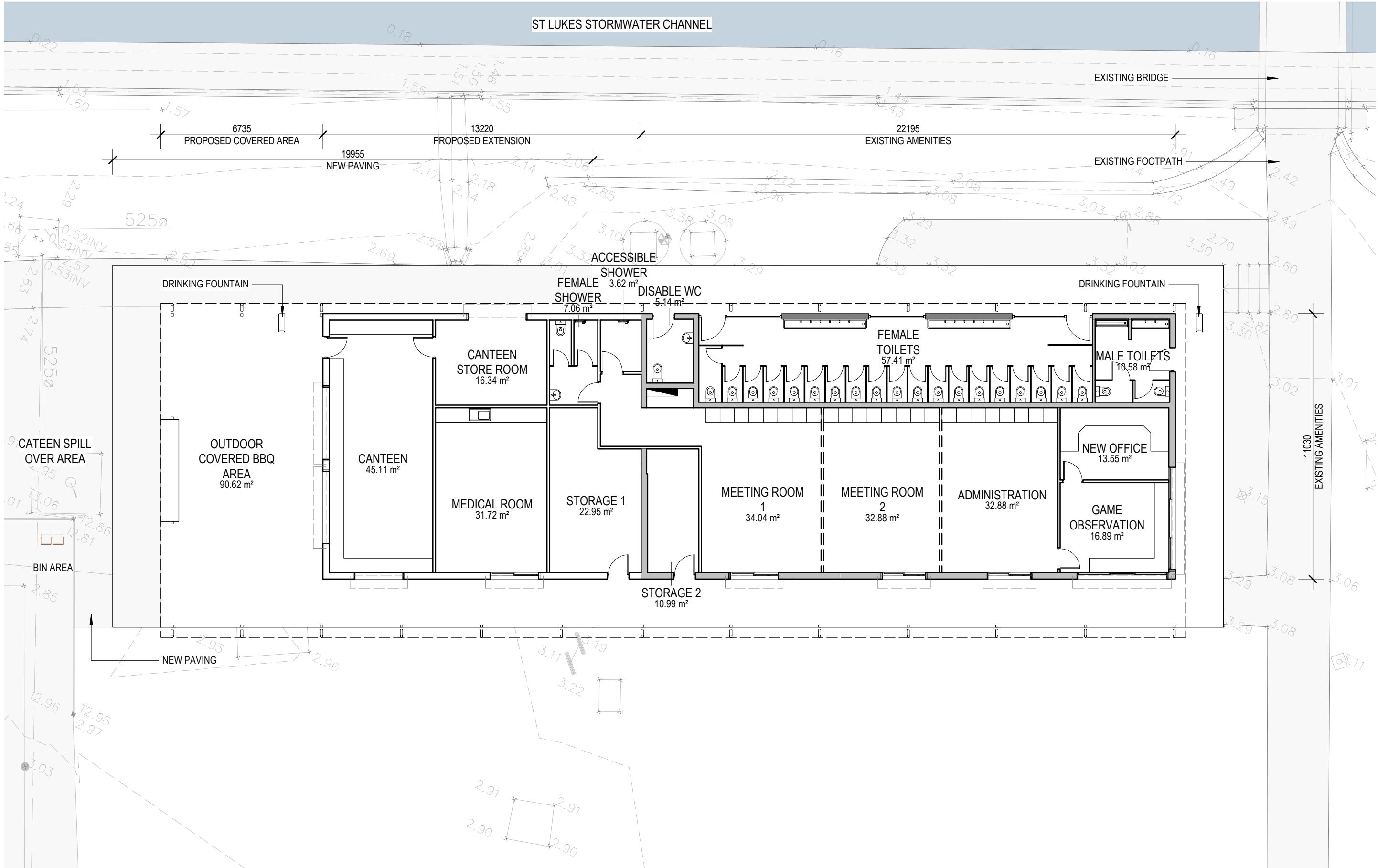


SITE PLAN.

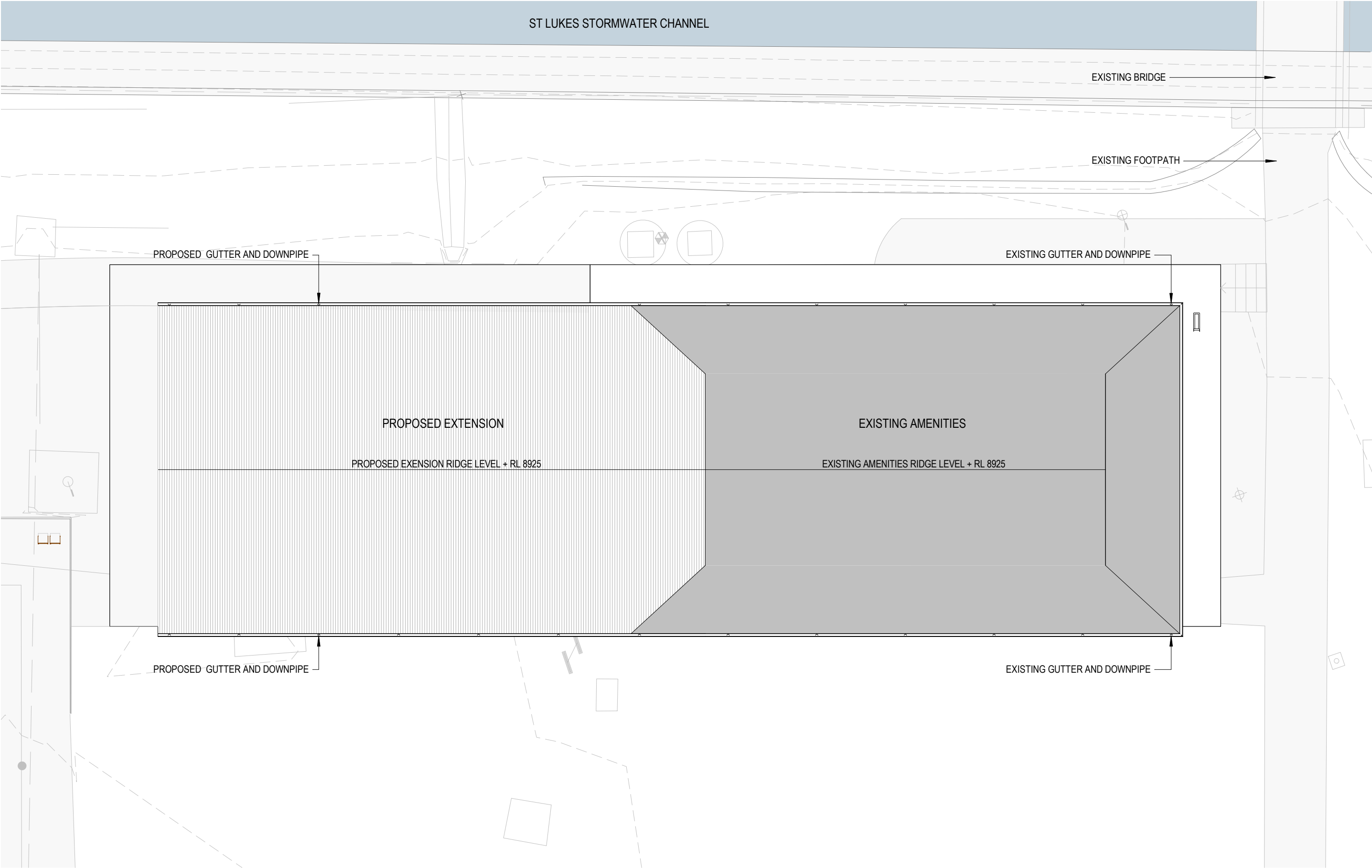

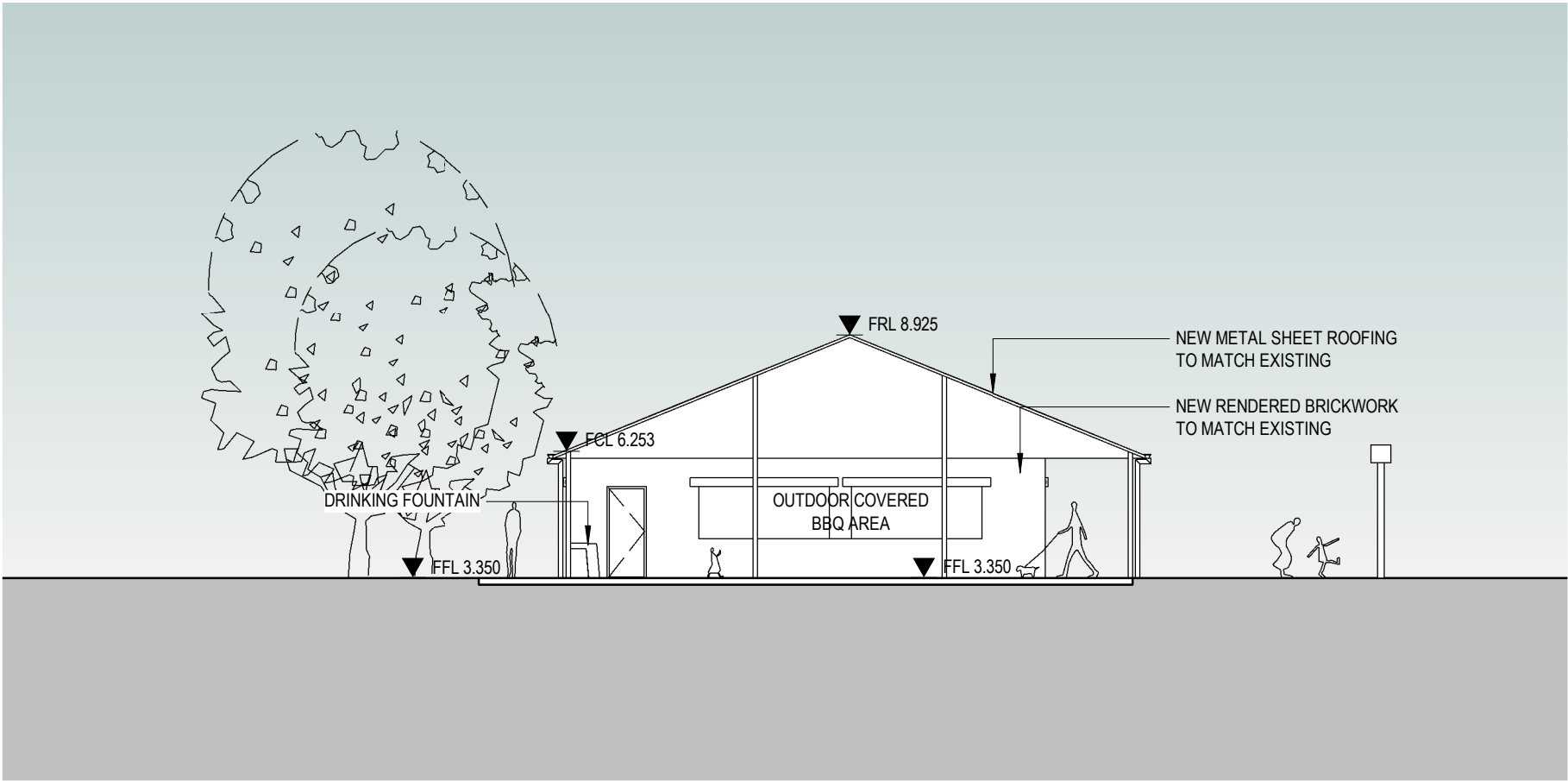
