## **Executive Summary**

This report, *Dog Park Improvements -Five Dock Park and Timbrell Park Community Engagement Outcomes Report*, outlines the community's feedback on improving the existing off-leash dog areas at Five Dock Park and Timbrell Park during the community engagement period from 1 to 21 July 2019.

#### Background

Since August 2018, the City of Canada Bay has collaborated with the community on strengthening off-leash dog provision in the City of Canada Bay and to inform the Dogs in Public Places Strategy, which is currently in development.

Prior to the above-mentioned consultation undertaken from 1 -21 July 2019, over 600 community members provided their feedback on off-leash dog provision and off-leash dog area trials undertaken via the engagement programs set out below:

- Five Dock Park Plan of Management Stakeholder, User Group and Community Consultation (9 August to 7 September 2018)
- Off-Leash Dog Trials at Timbrell Park (south-eastern section), Lower Phoenix Park, King George V Park and Kendall Reserve (24 October to 20 November 2018)
- Timbrell Park Off-Leash Dog Trial Extension (18 December 2018 to 17 April 2019)

Community feedback resulted in an additional three fenced dog-off leash exercise areas being established for our city, in Lower Phoenix Park, King George V Park and Kendall Reserve.

During the four off-leash dog trial consultation process, 186 community members provided quantitative feedback on general provisions in relation to off-leash dog areas:

- 93% of participants agreed that off-leash dog areas provide opportunities to socialise and strengthen community connections
- 90% of participants stated regular maintenance of off-leash dog areas was important to very important
- 85% of participants stated the provision of a drinking fountain with pet bowl was important to very important
- 84% of participants stated the provision of dog litter bags and bins was important to very important
- 79% stated natural shade was important to very important
- 70% stated signage outlining dog owner responsibilities was important to very important
- 70% of participants were concerned with dogs running onto nearby roads
- 69% stated a varied terrain/landscape was important to very important

At the Council meeting on Tuesday, 21 May 2019 the resolution set was to further consult with the community on:

- expanding the existing fenced off-leash dog exercise area at Five Dock Park and installing dog obstacles and agility equipment
- fencing options to the existing off-leash dog exercise area at Timbrell Park and installing dog obstacles and agility equipment

#### July 2019 Consultation Key Findings

#### **Overall Key Comments**

- 23% of participants stated that fenced off-leash dog parks do not work and that dogs just need open space
- 15% of participants stated this improving these offleash dog areas were a great initiative
- 15% of participants stated that there should be designated areas for small and large dogs
- 13% of participants stated that agility equipment was a waste of money and would not be used



## FIVE DOCK PARK

Five Dock Park is a well activated and valuable recreation and community space featuring:

- an active sports field with grandstand including toilets
- an under four year old children's playground
- a district skate park
- a half-sized basketball court
- extensive passive recreation spaces
- covered picnic and barbeque facilities
- existing fenced off-leash dog area
- the former Five Dock Bowling Club
- Five Dock Park Tennis Centre
- Five Dock Baby Health Centre

#### What the community has told us during previous consultations Five Dock Plan of Management – Discussion Paper Consultation

Options discussed with the community during the consultation process, included:

 retain the fenced off-leash dog park and enlarge the fenced area to the east to include a larger open grassed area.

Individual community comments included:

- extend east to/towards Ingham Ave
- enlarge dog park, but as two separated fenced areas for big/small dogs
- dogs need open space to run, not enclosures
- remove, too small, most dogs still using areas outside enclosure anyway
- reduce area
- reinstate former unfenced off-leash dog area near Tigers Five Dock Club
- install lighting to enable dusk/evening use of the fenced dog park.
- install irrigation within the fenced dog park to assist in grass and landscape maintenance.
- poor grass maintenance
- better surfacing, is muddy when wet.
- clarify and provide consistent signage (on-line, published and on-site)
- signpost park as off-leash dog area at entries
- enhance enforcement.

#### Recent off-leash dog consultations

- 'cage of rage' due to the small restricted area
- · 'dirt bowl' resultant from small area being repeatedly utilised without ongoing maintenance
- dogs require breadth of space for exercise

#### What was consulted on 1 - 21 July 2019

- Triple the size of the existing fenced off-leash dog park from 1,850sqm to approximately 5,600sqm
- Collaborate with the community on obstacles and agility equipment
- Consider the installation of lighting for evening use







#### Visitation to Five Dock Park Off-Leash Dog Area

- Currently 28% of participants who own a dog visit Five Dock Park daily, with 22% visiting a few times a week, 14% weekly, 28% occasionally and 8% never
- If the off-leash dog area was tripled in size, 40% of participants stated that their frequency of visitation would increase, 51% stated it would remain unchanged and 9% stated it would decrease. Participants have indicated a daily visitation increase from 26% to 38% and a few times a week visitation increase from 23% to 32%.
- If lights were installed, 40% of participants stated that their frequency of visitation would increase, 49% stated it would remain unchanged and 11% stated it would decrease. Participants have indicated a daily visitation increase from 26% to 36% and a few times a week visitation increase from 23% to 32%.
- If agility and obstacle equipment was installed, 30% of participants stated that their frequency of visitation would increase, 51% stated it would remain unchanged and 19% stated it would decrease. Participants have indicated a daily visitation increase from 26% to 38% and a few times a week visitation decrease from 23% to 21%.

#### **Activity Zones**

The overall three most important zones stated by the community were


- Open areas for running (82% ranked 1st and 2nd in importance and also the highest ranked for owners of dogs of all life stages)
- Play area climbing/ jumping/ balancing zone (44% ranked 1st and 2nd in importance with 64% of
  participants who own puppies ranking this 1st and 2nd, compared to 38% of participants who own adult dogs
- Small dogs/time out zone (32% ranked 1st and 2nd in importance with 75% of participants who own seniors
  ranking this 1st and 2nd and 38% of participants who own adult dogs ranking this 1st and 2nd). However,
  overall 48% of participants ranked this 5th and 6th, resulting in the least important zone


46% of participants ranked Rest Zones and Training/Education Zones as 5th and 6th in importance, resulting in the 2nd and 3rd least favourable zones.





- 36% stated stepping paws would not be utilised



## TIMBRELL PARK

Timbrell Park is a well activated and valuable recreation and community space featuring:

- multipurpose sports fields with amenity buildings including toilets
- the iconic all abilities Livvi's Play playground
- covered picnic and barbeque facilities
- existing off-leash dog area on the western side
  Livvi's Café with adjacent toilets
- large passive recreation area

#### • LIVES Care with adjacent tollets

#### What The Community Has Told Us During the Recent Consultations

Timbrell Park's existing off-leash dog area is located at the western side of Livvi's Playground, however many local dog-owners requested Council to explore the possibility of utilising the south-eastern section of Timbrell Park as an off-leash dog area as they believe it more preferable for dog exercise as it is larger and more protected from Henley Marine Drive. This area of the park is well utilised sports ground and therefore presented challenges.

The initial trial and consultation was undertaken from Wednesday, 24 October to Tuesday, 20 November 2018, with an extension to the trial undertaken from 18 December 2018 to 17 April 2019. Over 400 community members provided qualitative feedback during the consultation periods, with strong support for a permanent off-leash dog area at the trial location. During both trials and consultation periods there was a significant level of community interest and this issue evoked a high level of passion. It was recognised that the views expressed by many dog owners and many sporting stakeholders are in stark contrast, and a viable solution whereby both parties can be provided with their preferred outcome at this particular site was not identified.

Two options were presented at the Council Meeting held on 21 May 2019, with option two, 'Improve the existing off-leash dog exercise area at the western end of Timbrell Park as well as the existing fenced off-leash dog area in Five Dock Park' endorsed to be implemented, subject to further community consultation.

#### Sydney Water Iron Cove Canal Naturalisation Works

The off-leash dog area at Timbrell Park will be temporary as the channel is in need of repair and the area is part of the future Sydney Water naturalisation project. The naturalisation project will greatly improve waterway health, environmental outcomes and create a more diverse wildlife habitat, by replacing the concrete walls of the channel with natural looking banks comprised of sandstone rocks and diverse native planting.

The design also includes a wetland to improve waterway health and new walking and cycling paths for improved community connections. The project is currently in the final stages of detailed concept design. Construction will start in 2021 at the earliest.

#### What was consulted on 1 - 21 July 2019

- Seek direction from the community on fencing options including:
  - no fencing
  - installing 440 metres of linear fencing adjacent to Ramsay Road, Henley Marine Drive and the eastern footpath positioned west of Livvi's Café. Estimated cost is \$44,000.
  - installing 220 metres of linear fencing adjacent to Henley Marine Drive and the eastern footpath positioned west of Livvi's Café with the western fence line aligned with New Jersey Road. Estimated cost is \$22,000.
- · Collaborate with the community on obstacles and agility equipment
- Consider the installation of lighting for evening use

Participants have indicated a daily visitation decrease from 21% to 19% and a few times a week visitation increase from 19% to 34%.
- If lights were installed, 42% of participants stated that their frequency of visitation would increase, 51% stated it would remain unchanged and 8% stated it would decrease. Participants have indicated a daily visitation increase from 21% to 25% and a few times a week visitation increase from 19% to 26%.
- If agility and obstacle equipment was installed, 34% of participants stated that their frequency of visitation would increase, 49% stated it would remain unchanged and 17% stated it would decrease. Participants have indicated a daily visitation increase from 21% to 25% and a few times a week visitation increase from 19% to 21%.

#### Key Data:

- Only 6% of the 401 community members who participated in the previous consultations in relation to Five Dock Park and Timbrell Park, participated in this consultation.
- 92.5% of participants are residents of the City of Canada Bay
- 68.9% of participants are female with a median age bracket of 45-54 years
- 94.3% of participants own a dog with on average 1.2 dogs per household
- 64% of survey respondents own an adult dog, with 28% owning puppies and 8% owning seniors

Over the past nine months we have collaborated with community members on strengthening off-leash dog provision in the City of Canada Bay and to inform the Dogs in Public Places Strategy, which is currently in development.

During this period, over 600 community members have provided their feedback on off-leash dog provision and trials were undertaken via the engagement programs set out below:

- Five Dock Park Plan of Management Stakeholder, user group and community consultation (9 August to 7 September 2018)
- Off-leash dog trials at Timbrell Park (south-eastern section), Lower Phoenix Park, King George V Park and Kendall Reserve (24 October to 20 November 2018)
- **Timbrell Park off-leash dog trial extension** (18 December 2018 to 17 April 2019)

Community feedback has resulted in an additional three fenced dog offleash exercise areas being established in Lower Phoenix Park and King George V Park in Rhodes, and Kendall Reserve in Cabarita.

At the Council meeting on Tuesday, 21 May 2019 Council discussed the outcomes of the Timbrell Park off-leash dog trial extension, and the following resolutions were made:

- 1. THAT the existing fenced off-leash dog exercise area at Five Dock Park be expanded and that dog obstacles and agility equipment be provided.
- 2. THAT the existing off-leash dog exercise area at Timbrell Park have fencing installed and dog obstacles and agility equipment provided.
- 3. THAT Council ensure the Dogs in Public Places Strategy currently being developed incorporates consideration of managing mixed-use public open space to accommodate off-leash dog areas at specific times.

- 8. THAT prior to any further works in Timbrell Park and Five Dock Park being undertaken, consultation be conducted with users of the parks.
