4. The entries will be judged by a panel, made up of one judge from each of the following teams at the City of Canada Bay: Traffic and Transport, Place Management and Media & Communications.
5. The voting will be done by a popular vote by the panel and the decision will be final. \*Except for the 'People's Choice Award' which will be judged by the number of 'Likes' received on the City of Canada Bay's Facebook page for an individual entrant across all competition categories.
6. The City of Canada Bay accepts no liability whatsoever for any costs incurred in the preparation of any entry or any other losses arising from the entry.
7. The City of Canada Bay reserves the right to not announce any winner.
8. Entrants must not seek to approach or influence any panel member during the judging period of this competition. No correspondence will be entered into between the panel and entrants except as set out in these terms & conditions.
9. The panel reserve the right to disqualify any entrant submitting an entry which, in the opinion of the judges, includes objectionable content, including but not limited to profanity, nudity, potentially insulting, scandalous, inflammatory or defamatory images or language. The judges' decision will be final and no correspondence will be entered into.
10. ASSESSMENT CRITERIA – all entrants will be judged according to the following criteria:
  - Creativity of the submitted poster
  - Ability to illustrate the topic
  - Design techniques applied.
11. Original artwork submissions can include but not limited to:
  - Digital graphic art (design or drawing which may include collage)
  - Hand drawn art (crayon, coloured pencil, marker, paint etc)
12. Size of poster to be submitted is A3 (297 x 420 mm) or A4 (210 x 297 mm)
13. All entries become and remain the property of the City of Canada Bay and agencies associated with this promotion and no entrant shall object or take any steps to prevent the use, development, alteration of the entry by Council.
14. By entering the competition, the entrant warrants they are the owner of all intellectual property rights in the artwork or have obtained all necessary approvals to permit the use of design in any competition. Artwork that infringes intellectual property rights will be immediately removed from the competition.
