Executive Summary

This report outlines the level of support and suggestions received during the off-leash dog park trial in Henley Park, Concord from 10 February - 15 March 2020.

Project Context

Council's recently adopted Dogs in Public Places Strategy seeks to reduce confusion around where and when dogs are allowed off-leash in our local parks, and has successfully opened several new areas for dogs to exercise throughout the City. As part of developing the Dogs in Public Places Strategy, we investigated whether there is an adequate supply of dog parks in the City.

Within the strategy, Henley Park, Concord was identified as a possible site for an off-leash dog park due to performance measures outlined in the draft NSW Greener Places – Open Space for Recreation Guide. One of the criteria refers to household proximity to dog exercise areas. It states that there should be: “Access to an off-leash opportunity within 10 minutes (800m) walking distance of all houses.”

The map below shows the portion of our City that falls within an 800m radius of an existing off-leash dog exercise area. The strategy identifies an opportunity to explore options for the establishment of a dog off-leash exercise area in Henley Park to address this need.

Level of Support

Number of submissions : 46

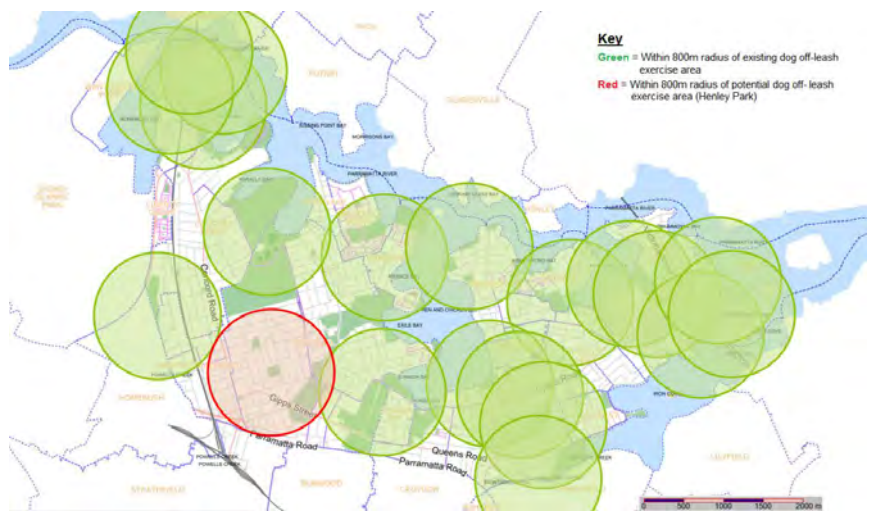


Top 6 elements needed for a successful off-leash dog park

1. Is entirely fenced in = 13.78/16
2. Located within walking distance = 13.69/16
3. Not fenced in - is a designated location that is available for others to use = 13.40/16
4. Includes a drinking fountain with pet bowl = 12.78/16
5. Provide dog litter bags and bins = 12.77/16
6. Has natural shade = 12.3

COMMUNITY ENGAGEMENT FINDINGS

About Henley Park, Concord

Henley Park is located in Concord on the corner of Flavelle and Pitt Street. Originally a general cemetery, it became a park in 1938.

A large open grass park with dedicated play equipment lends itself to family fun or birthday parties.

There is a gated children's playground in the park.

No organised sports are played in the park, and was therefore a strong option for an off-leash dog park.

Passive surveillance of the park on a Sunday identified varied activities taking place; including drone flying, exercise, dog walking, children's playground visits and frisbee.

For the purposes of the trial, a temporary bin with dog bags and signs were installed in the park.



Current Behaviour In The Park

Of the 33 respondents who walk their dog in Henley Park, 40% do so both on-leash and off-leash currently, while 30% of dog walkers only walk their dog off-leash.

Other activities were under represented in the park, with the children's playground only being used by 9 respondents. This is likely due to lack of interest in the trial.

Level of support for the park becoming an off-leash park based on park usage & proximity

- 90% of respondents who use the park rarely support the trial indicating that park usage by dog owners would increase if the park became an off-leash dog park permanently
- Over 50% of children's playground users indicated they would support an off-leash dog park
- 80% of daily users also support an off-leash dog park
- 75% of those who use the park several times a week also support an off-leash dog park
- 7/8 perimeter residents support an off-leash dog park.

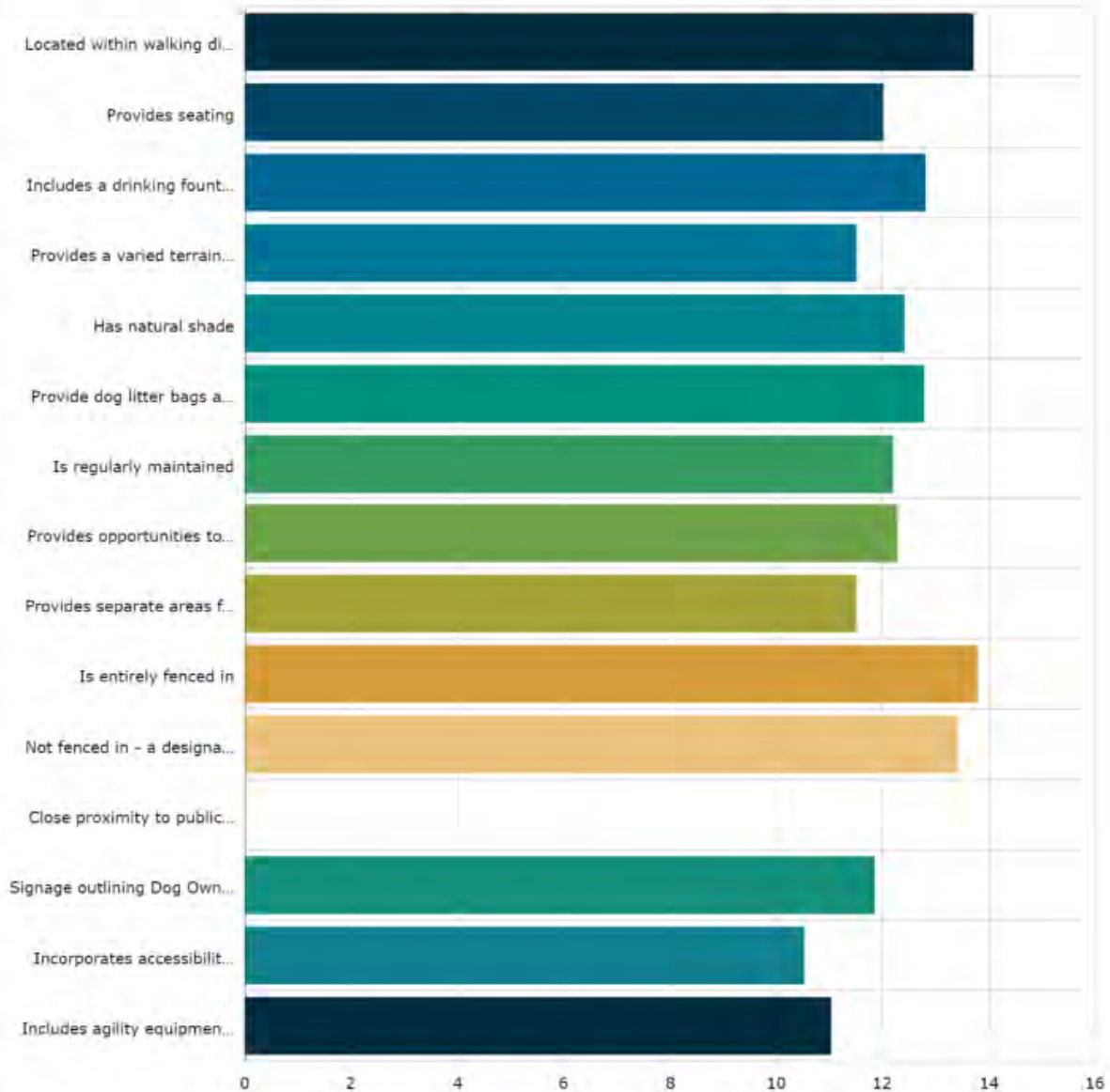

Fencing

Arguments for and against fencing the park, should it become an off-leash area, were posed throughout the consultation. Some participants would like the entire park fenced, while others think a section would be suitable. However, the issue of wear and tear in other local fenced dog areas was mentioned several times. Qualitative feedback tagging is as follows:

Entirely fenced	- 13 mentions
No fencing (but support off-leash dog park)	- 6 mentions
Some fencing	- 18 mentions
Flavelle St boundary fence	- 7 mentions

A Flavelle Street boundary fence was suggested several times due to the street posing the most danger for dogs running onto the road:

“In that context I respectfully submit that fencing off 25% of the Park in the north east corner area of the Park adjoining Flavelle Street and 28 Flavelle Street would create a significantly large off-leash area with several shade trees and leave 75% of the Park including the existing playground and numerous shade trees available for passive recreation.”

“Fencing, at least along Flavelle Street”

Various options were proposed for “some fencing” including:

“I have a dog and would love for the whole park to be off leash... However that would not be great for some others. A large enough area (40% houses with dogs so 40% of the park??) could be fenced off to create a manageable area while still leaving the rest of the park for those who want to picnic or other without furry friends.”

“Fencing off a portion of the park for the pets and leave the rest to play ball etc.”

“This is a great initiative. Thank you for taking on board the recommendations for open space provision. My answers above are based on a large enough area that is fenced for dog play. As much as I would love the dog area to be unfenced, realistically this needs to consider people who don't like dogs and don't want to be accosted by an off leash dog (however friendly that dog might be!!)”

Amenities

Beyond fencing and location, the most popular elements for a successful dog park are a drinking fountain, litter bags and bins and natural shade:

1. Is entirely fenced in = 13.78/16
2. Located within walking distance = 13.69/16
3. Not fenced in – a designated location that is available for others to use = 13.40/16
4. **Includes a drinking fountain with pet bowl = 12.78/16**
5. **Provide dog litter bags and bins = 12.77/16**
6. **Has natural shade = 12.38/16**

- Water fountain

A "water feature" that extends beyond a dog bowl filling station was suggested to keep dogs cool in summer.

- Dog litter bags and bins

These would be provided should the trial be successful.

- Natural Shade

If the whole park was not an off-leash dog park, natural shade could be provided in the corner on the Castlereagh St border. However this area is quite close to the Children's Playground.

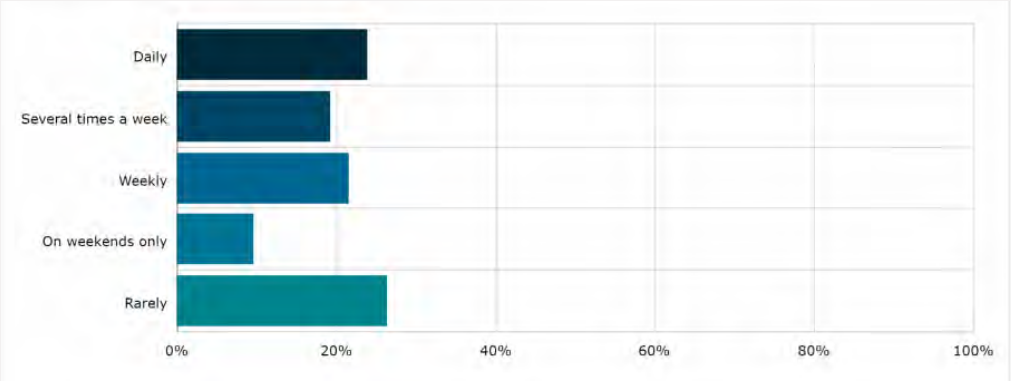
15% of respondents did not support Henley Park as a dog park, with key feedback being a need to maintain shared space for all of the community and dogs being deterrent to some people using the park.

"By having an off-leash dog park it becomes a deterrent for families, community groups, school groups and other social groups from using the park as they may fear constant interruption by dogs. Dog owners have a responsibility to control and care for their pet and where many dog owners are responsible, there are dog owners who believe that their dog should be allowed the freedom to run free. These dog owners do not appreciate the rights of individuals who may feel uncomfortable walking through a park where dogs are off-leash and may not want dogs running up to them."

"Park is used for many activities by many locals throughout the day, it should stay as a multi-use park."

"Sacrificing the entire park would greatly compromise these varied activities, a more suitable location for this would be a fenced off portion of Central park adjoining the Bowling club, Central park is by virtue of its name, central to the location and conducive to this use."

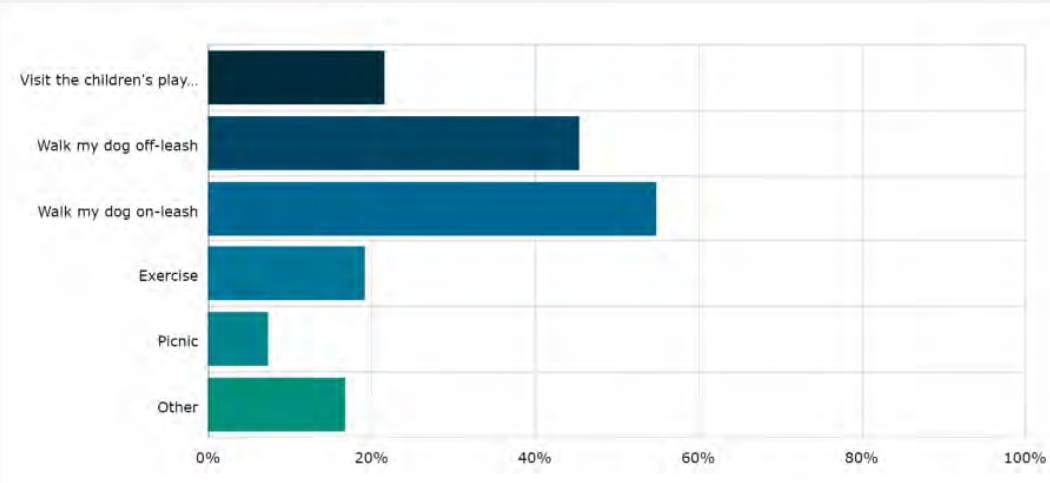
Henley Park Community Feedback - current and future usage

"Kendall Reserve should have fake grass/astro turf as it's a dust bowl"

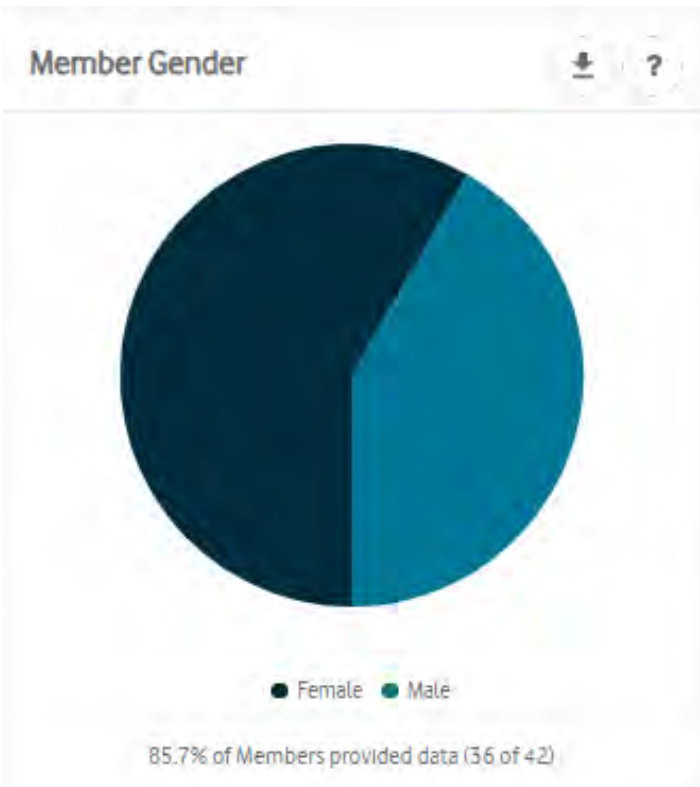
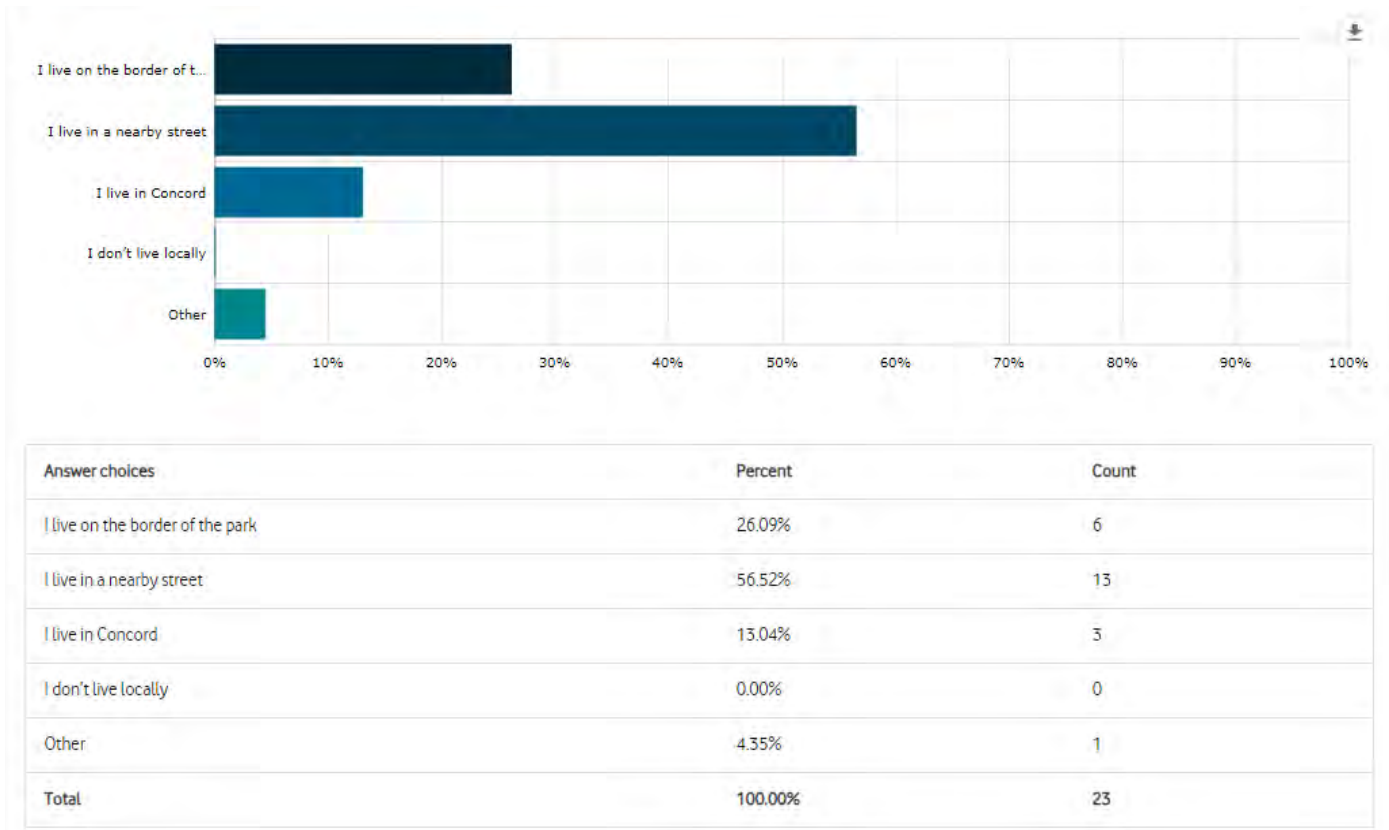

1. Participant Breakdown

- 88% Concord residents

2. Drop In Report - Sunday, 23 February 3.30 - 5.30PM at Henley Park

Council officers met with 15+ groups of residents to discuss the trial and potential outcomes of community feedback. The main question posed was: if the trial is successful and the community supports the park becoming an off-leash dog park, would the park be fenced? If so, how much of the park would be fenced?

Council officers explained that the feedback collected would be analysed and a recommendation made to Council based on community feedback. The formation of an off-leash dog park would also need to incorporate the principles outlined in the recently adopted Dogs In Public Places Strategy with reference to fencing, amenities, enforcement etc.

General feedback was mixed; perimeter residents would like the park to remain as is, dog owners with smaller dogs were happy without a fence, while dog owners with larger or more athletic dogs would like a fence – even a small area of the park so as not to disturb passive recreation and shared spaced principles.

Council Officers encouraged residents to provide formal written feedback online at Collaborate Canada Bay. Councillor Yap attended the drop-in and discussed the trial with several groups of residents also.

Hi,

The draft NSW Greener Places – Open Space for Recreation Guide states that there should be: "Access to an off-leash opportunity within 10 minutes (800m) walking distance of all houses." Henley Park was strategically identified in the Dogs in Public Places Strategy and chosen for this trial (as opposed to other parks) largely because residents within 800m currently don't have this opportunity, unlike residents in the majority of other locations in the City of Canada Bay.

There are other dog parks in Canada Bay that successfully cater for a variety of uses for both dog owners and non-dog owners, and this would also be the intended outcome if this site was to become a permanent dog park.

Council wishes to hear from the community before a decision is made so that all concerns can be considered. We encourage everyone to take the opportunity to complete the survey during the trial period.

In accordance with legislation and Council's Dogs in Public Places Strategy, dogs are required to be under effective control of their owner when they are in a public place. This includes off-leash exercise areas. Non-compliance can be reported to Council and our enforcement officers will investigate. Burwood Police can also be contacted if there is a serious issue.

Answer

Hi Rosa,

There are no formal sporting activities that occur at Henley Park, so informal sporting activities can continue to occur in conjunction with the trial. The entire park except for the fenced Children's playground can be used as an off-leash exercise area during the trial period and there are no time restrictions.

A water fountain is available near Pitt Street but it does not include a dog bowl. It will be upgraded to include a dog bowl if the site becomes a permanent off-leash exercise area in the future. A temporary bin with doggy bags will also be provided during the trial period.

Once we receive feedback from the community around the trial and how it could work into the future, we'll determine what parameters (if any) are needed for the park regarding off-leash areas/times etc. More permanent amenities would also be included if the trial is successful.
